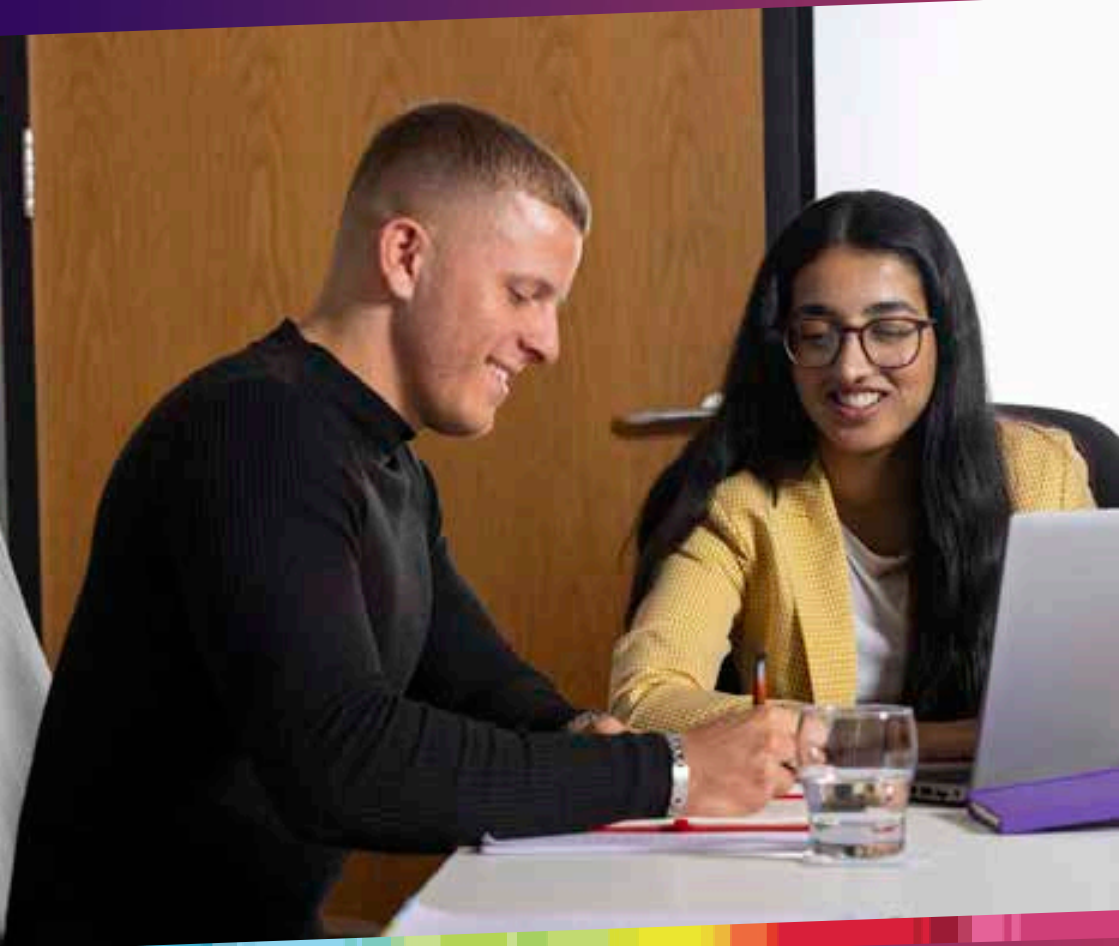

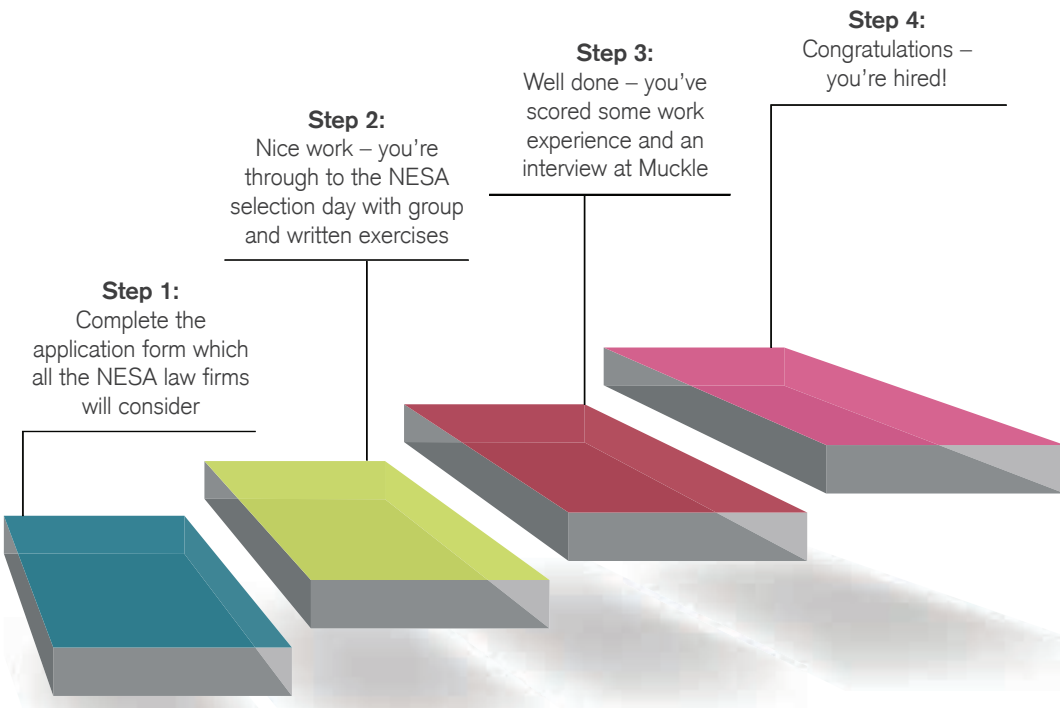
become a solicitor apprentice

The Trailblazer Level 7 solicitor apprenticeship is a relatively new route into the legal profession. Since 2017, Muckle has worked with a group of law firms to deliver the North East Solicitor Apprenticeship (NESA) programme and offered a number of apprenticeships across the region. This year we're delighted to be running the scheme again, working with Northumbria University, who will provide academic support to apprentices recruited in September 2025.

Solicitor apprenticeships in a nutshell

- **6 of the best** - it's a 6 year programme of work based learning and part time study incorporating an LLB (Hons) in Legal Practice and leading to qualification as a solicitor
- **Earn and learn** - take home a competitive salary and have no university fees to pay
- **Opportunity knocks** - successfully complete your apprenticeship and you have a great chance of securing a permanent job with us

4 steps to 'you're hired'



Supporting you all the way

You'll have a supervisor to guide and support you. They'll also provide regular reviews and feedback to let you know how you're doing.

As an apprentice, you'll carry out supervised work-based learning to meet the Solicitors Regulation Authority's competence statement and you'll also build up a work-based assessment portfolio. As well as exams throughout the apprenticeship, there will be Solicitors Regulation Authority assessments that you'll need to pass.

You'll have to work hard, but there are plenty of non-work activities going on at Muckle to help strike the perfect balance. We'll even pay you to study, although you'll also need to use your own time for that too.

recruitment q&a

How many apprentice solicitors are you recruiting?

We are looking to recruit one solicitor apprentice at Muckle, to start in September 2025.

What are you looking for in candidates?

The solicitor apprenticeship is available to people with a minimum of five GCSEs (or equivalent), grades C/5 or above, including Maths and English. You should also be expecting, or have already achieved, at least 3x B grade A Levels (or equivalent) or a minimum of 120 UCAS points. We are looking for people with strong communication skills, enthusiasm, personality and a positive attitude. Finally, we are also looking for a genuine motivation to work at Muckle.

Will you accept lower grades?

Ideally applicants will have obtained a minimum of 3x B grade A Levels (120 UCAS points), or will be predicted to achieve them. However, we're willing to listen if there are mitigating circumstances.

I don't have any work experience. Will my application be adversely affected?

Not at all, but we are interested in other experiences you've had and how they might help you in the workplace, such as community volunteering or a project you led at school.

I have a law degree. Can I still apply?

No. Sorry, anyone with a law degree, CILEx Level 6, GDL, LPC or BPTC is not eligible to apply.

Do you pay travel expenses for interviews?

No. Sorry, we don't reimburse travel expenses for interviews.

Before you start

We consider you to be a part of our team from the moment you accept our solicitor apprenticeship offer, so expect us to keep in touch before you join. There might be opportunities to spend time in the firm before you officially start, and we'll make sure you're invited to any legendary Muckle social events that come up. That way you can get to know as many people as possible, as soon as possible, including your mentor.
